<u>98/29/EC</u> Council Directive of 7 May 1998 on harmonisation of the main provisions concerning export credit insurance for transactions with medium and long-term cover "medium and long-term Directive"

Compliance with the Commission Communication on short term export credit insurance (OJ C 281, 17.9.1997, as amended subsequently)

Compliance with the OECD Arrangement on Officially Supported Export Credits: This is formally speaking a Gentlemen's Agreement (= soft law instrument), in which the EU as a whole is a Participant. The EU, however, regularly transposes modifications to this Arrangement into European law.
